The objections, if any, shall be submitted in writing in the office of the **Child Development Project Officer, Langate**, on or before **21.09.2026 up to 04:00 PM**, against proper receipt.

No objection shall be entertained after the expiry of the prescribed date and time. Thereafter, the selection process shall be proceeded with/finalized in accordance with the applicable rules, orders and Government instructions.

The Tentative Selection-cum-Overall Merit List shall, however, remain **subject to the outcome of any court case, litigation or other legal proceedings, if any, pending or instituted in the matter**.
