Whereas, Pursuant to the Human Resource Policy for recruitment of Sanginis (Anganwadi Workers/AWWs) and Sahayikas (Anganwadi Helpers/AWHs) issued vide Government Order No. 222-JK(SWD) of 2022 dated 30-11-2022 and Government Order No. 103-JK(SWD) of 2023 dated 28-04-2023, the vacancies of Sanginis Sahayikas (Anganwadi Workers/AWHs) have arisen due to various reasons, i.e., attaining the age of sixty, resignation, death, etc.

Whereas, this office submitted the vacancy position to the District Programme Officer, Kupwara vide No: CDPO/Poshan/SGM/Adv/2026/535-46 Dated:-23-06-2026, who further submitted it to the Mission Director, Poshan Jammu and Kashmir for accord of approval for recruitment of Sanginis (Anganwadi Workers) at vacant positions.

Whereas, the Mission Director, Poshan J&K, accorded approval for the recruitment of Sanginis (Anganwadi Workers) vide letter No. MD/POSHAN/22263-73 Dated: 18-06-2026 which was further communicated by the District Programme Officer, ICDS Kupwara to this office vide letter No. DPO/POSHAN/KUP/26/4749-59 Dated: 19-06-2026.

Whereas, this office advertised (01) vacant post of Sanginis (Anganwadi Workers) for Anganwadi centre, Thandoosa-A (PH. Hayathpora Ward No. 08 vide this office advertisement notification No. 02 of 2026 Dated 23-06-2026, published in daily newspapers Kashmir Convener, Kashmir Horizon & Morning Kashmir on 26-06-2026 and also uploaded on departmental/district websites for wide publicity.

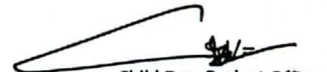
