Subject: Publication of Final Merit List for Inviting Objections from the General Public on selection of 10 vacancies of Sanginis under 4th Phase 2025

1. Whereas 10 vacancies of Sanginis, duly approved by the Mission Director Poshan J&K, were advertised vide Notification No. ICDS/ESTT/Btw/2025/343-347 dated 18.02.2025 through all mediums for inviting applications from eligible candidates of respective wards.

2. Whereas, a total no of 55 application forms were received by this office against the said 10 vacancies within the stipulated timeline of 15 days.

3. Whereas, on the basis of supported documents a tentative merit list was framed by this office, which was subsequently approved by the District level selection committee and published through respective mediums, including newspapers, to invite objections from the general public against the said list and in response to the said notification, no objection was received by this office within the stipulated time limit of 10 days.

4. Whereas, a final merit list was framed and was accordingly Put before the District level selection committee and the Committee after thorough scrutiny, approved said list.

5. Whereas, the District level committee prepared the final merit list/selection list, which was approved by the designated members, and after completion of requisite formalities, the said list was submitted to the ADDC Srinagar for grant of approval.

6. Whereas, the ADDC Srinagar, after scrutinizing the final merit list and all enclosed documents, pointed out certain discrepancies in the selection process, including the publication of the final merit list, as the same could not be uploaded on the departmental website due to a technical reason. Besides, the receipts were not available/received from the concerned officials to whom the final merit list was handed over for inviting objections.

7. Whereas, the ADDC Srinagar vide letter No. ADDC/PS/25/1543-44 dated 21-11-2025 while raising certain observations, sought necessary direction from the Commissioner/Secretary to the Government, Social Welfare Department, and it was recommended that whether the final merit list shall be approved or the vacancies shall be re-advertised.

8. Whereas, the Administrative Department, after thoroughly examining the recommendations of the ADDC and all enclosed documents, conveyed the directions to MD Poshan J&K vide letter No. SWD-iCDS /54/2025-01 (7709413) dated 08.09.2026 wherein it was prescribed that "Prior to approaching the approving authority, the Member Secretary of the Selection Committee shall ensure strict adherence to the provisions of the H.R. policy governing the engagement of Sanginis, and it was further directed that the following procedural requirements shall be followed in the instant case:

1. The final merit / selection list shall be uploaded on the official website of the department/ Mission Poshan.
2. The said list shall be displayed in the offices of all the members of the District selection committee, the concerned panchayat ghars and ward offices and also shall be published in leading daily news papers.
3. Objections shall be invited from the general public within a period of 10 days from the date of publication/display of the selection list.

Now, in view of the above statements and directions of the Administrative Department forwarded by the M.D.Poshan J&K Srinagar vide letter No MD/Poshan/2026-27 dated 14.09.2026. objections are invited from the general public with regard to the selection of Sanginis, as mentioned in the final merit list enclosed herewith within a period of ten days from date of publication, with respect to the ward position, qualification (not more than graduation) married outside ward and other related parameters as per H. R. Policy may be filed in the office of the undersigned within a period of 10 days from the date of publication of this notification and after the Completion of stipulated time line No objection will be entertained and the final merit list as per the direction of Administrative Department shall be submitted to ADDC Srinagar for grant of approval.

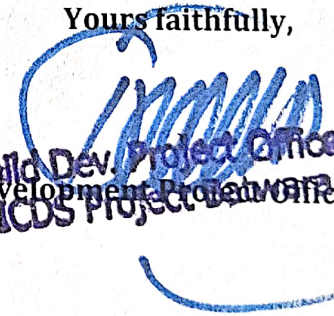
