Sanction is hereby accorded to release of funds to the tune of **Rs.1581.98 lacs (Rupees Fifteen Crore, Eighty One Lac, Ninety Eight Thousand) only** and placement of the same at the disposal of District Programme Officers of Jammu/Kashmir Province for its further placement to Child Development Project Officers of Kashmir/Jammu Province as Additional Central Assistance (ACA) under ICDS Supplementary Nutrition Programme (SNP) for its utilization during the current year 2016-17 as per annexure "A" to this order:-

The release of funds is subject to the fulfillment of the following conditions:-

- 1. The DDO shall ensure that in case of adverse analytic report no payment should be made.
- 2. That in case of analytic report being awaited no payment should be made until analytical report clears the supply.
- 3. That the funds are utilized exclusively for the purpose for which these were originally released.
- 4. That all the codal formalities are observed before incurring the expenditure.
- 5. That no diversion or re-appropriation of funds is allowed in any case without the prior approval of the competent authority.
- 6. That the DDOs shall complete all the codal formalities before presentation of bills at the Treasury.
- 7. The utilization certificate of these funds should reach this office within fortnight.
- 8. No funds shall be released without the prior approval of the DLPC where the supplier has failed to make full supplies under the supply order issued to him by the DPO/CDPO.
- 10. No payment shall be released on account of purchase of rice from open market.
