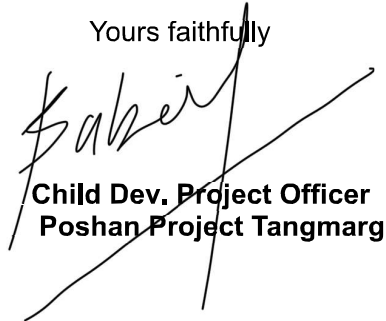

Whereas, the Mission Director, Poshan J&K, accorded approval for the recruitment of Sanginis (Anganwadi Workers) vide letter No. MD/POSHAN/47135-46 Dated: 24-12-2025 which was further communicated by the District Programme Officer, ICDS Baramulla to this office vide letter No. PO/ICDS/4101-03 Dated: 27-12-2025.
