Criteria for Selection of Sanginis (Anganwadi Workers) Shall remain as envisaged in the Govt. Order No. 222-JK(SWD) of 2022, Dated:30-11-2022 and Order no. 103-JK(SWD) of 2023 Dated 28.04.2023 i.e,

- ❖ Women candidates in the age group of 18-37 years shall be eligible (age shall be calculated on the 1st day of calender year i.e 01-01-2025).
- ❖ The candidate should be a domicile of the UT of J&K.
- ❖ The candidate should be a resident of the Electoral Ward where AWC is located.
- ❖ Minimum Education qualification should be 10+2 and maximum graduation.
- ❖ Weightage shall be given on the basis of marks obtained in 10+2 and selection shall be granted purely on academic merit basis & there shall not be any interview.
- ❖ In case eligible candidate is available within the family of retired AWW the said candidate shall qualify for additional two percent points.
- ❖ Candidates with qualification higher than graduation shall not be considered.
- ❖ In case of tie in merit of the eligible candidate, candidate with higher age will be preferred.
