

Sanction is hereby accorded to the release of funds to the tune of **Rs.17.90 lacs (Rupees Seventeen Lacs and Ninety Thousand )** only and placement of the same at the disposal of Deputy Director (ICDS) Jammu/Kashmir, **District Programme Officers of Jammu/Kashmir Province** for its further placement to Child Development Project Officers of Jammu/Kashmir province to meet the expenditure under object head Office Expenses (O.E) state share under ICDS General during the current financial year 2016-17 as per annexure "A" and "B" to this order. The release of funds is subject to the following conditions:-

1. The expenditure shall be made strictly as according to the classification under which funds have been authorized by the Finance Department. No omissions/commissions or diversions shall be made under any pretext unless specifically and separately authorized.
2. Treasury Officers shall not entertain bills without complete classification under which funds have been placed with the Treasury.
3. There should be expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.
4. DDOs shall complete all the codal formalities before presentation of bills at the Treasury.
5. All the controlling officers/DDOs shall conduct periodic reconciliation of remittance and drawals with the treasury and the office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.
6. Controlling officers shall strictly inspect and supervise the public receipts and expenditure with reference to the appropriation Act 2015 and all the standing rules and regulations.
7. All the sanctions/approvals and clearance should be in place before drawal of money from the treasury.


