The release of funds is subject to the fulfillment of following conditions:-

- 1. That the funds are utilized exclusively for the purpose for which these were originally released.
- 2. The DDO shall ensure that the funds now released are not utilized for pending issues where any administrative consent or approval is required..
- 3. The DDO shall ensure that the salary of the employee transferred shall be drawn at their new place of postings only
- 4. The funds now released or inclusive of DA/Pay arrears of employees pending if any.
- 5. That all the codal formalities are observed before incurring the expenditure.
- 6. That no diversion or re-appropriation of funds is allowed in any case without the prior approval of the competent authority.
- 7. That the DDOs shall complete all the codal formalities before presentation of bills at the Treasury.
- 8. The utilization certificate of these funds should reach this office within fortnight.
