- 1. That the funds are utilized exclusively for the purpose for which these were originally released.
- 2. That all the codal formalities are observed before incurring the expenditure.
- 3. That no diversion or re-appropriation of funds is allowed in any case without the prior approval of the competent authority.
- 4. That the DDOs shall complete all the codal formalities before presentation of bills at the Treasury.
- 5. No new work is taken up for execution without completion of ongoing works.
- 6. The utilization certificate of these funds should reach this office within fortnight; and The expenditure shall be debited to Account Head mentioned below:-
