Whereas, Pursuant to the Human Resource Policy for recruitment of Sanginis (Anganwadi Workers/AWWs) and Sahayikas (Anganwadi Helpers/AWHs) issued vide Government Order No. 222-JK(SWD) of 2022 dated 30-11-2022 and Government Order No. 103-JK(SWD) of 2023 dated 28-04-2023, the vacancies of Sahayikas (Anganwadi Workers/AWHs) have arisen due to various reasons, i.e., attaining the age of sixty, resignation, death, etc.
