Subject: Implementation of Hon'ble High Court order dated: 29-09-2015 passed in LPASW NO:82/2005, MP No.82/2005, C/W LPASW No.339/2002 MP No.390/2002, titled Rajesh Kumari V/S State and Others.

Order NO: 590-SMD of 2017.

Dated : 07-02-2017.

Whereas, the above titled case was disposed of by the Hon'ble High Court on 29-09-2015, the operative part of which is reproduced as under:

".....The respondents however shall consider appellants claim for appointment against the posts of Supervisors available on the date respondents were appointed or have become available thereafter and lying vacant as on date in accordance with rules, so that the appellants who have prosecuted the matter for the last years are not left with any bitterness. Let such exercise be completed within eight weeks from the date of receipt of copy of this order."

Whereas, after receiving the judgment, a detailed report was sought from the District Programme Officer (ICDS) Jammu.

Whereas, the District Programme Officer (ICDS) Jammu furnished a detailed factual report to this office along with the seniority list of Anganwadi Workers, after scrutinize the records following have emerged :-

1. That the Petitioner (Rajesh Kumari) has been actually engaged as Anganwadi Worker vide order No; CDPOJ/17/40 dated: 17-09-1990, with qualification as graduate and figuring at S.No.09 in the seniority list of graduate Anganwadi Workers.
2. That as per the report, submitted by the then District Programme Officer Jammu, Anganwadi Workers figuring at S.No.1 (Smt. Chanchalla Devi)

and S.No.6 (Smt. Sandhya Devi) have already been elevated as supervisors against the available vacancies .

3. That the Anganwadi Workers figuring at S.No.2,3,4,5 were disqualified on the ground that they have obtained the graduation certificates from the Universities which were not recognized by the UGC,(University Grants Commission) Govt. of India.
4. That the Anganwadi Worker (Smt. Gharo Devi Wd/o Late Sh. Dev Raj R/o Mattu-B Anganwadi Worker, Mattu-B, ICDS Project Khour) figuring at S. No. 07 in the seniority list has not been yet elevated as supervisor and the Anagnwadi Worker figuring at S.NO.08 (Smt. Sushma Devi) has already expired.Due to the above the position emerged as under:-

Now the two senior most Anganwadi Worker of Jammu district are hereby allowed to work as supervisors in their own pay and grade plus charge allowance as admissible with immediate effect, pending clearence by DPC (Departmental Promotion Committee) constituted by the Government vide order No: 206-SW of 2016 dated:26.10.2016.

before the competent court and shall not confer any preferential claim on the Incumbent for regularisation & selection on substantive basis. Their promotion shall be accorded as per rules in vogue and strictly as per their respective seniority position. i.e; other such eligible anganwadi worker.
