

1. The funds shall be utilized for execution of the scheme strictly as per the originally approved Components and according to GOI's prescribed guidelines.
2. The disbursing agencies/officers must satisfy themselves that the beneficiaries are otherwise eligible as per provisions of the scheme.
3. No diversion/re-appropriation of the funds so released shall be allowed without the prior approval of the Competent Authority
4. All codal formalities shall be fulfilled before incurring the expenditure.
5. That a status report about the scheme and physical/financial progress report including cumulative expenditure and physical achievements shall be submitted to the State Mission Directorate regularly on monthly/quarterly basis.
