1. The DPOs/CDPOS shall indicate in his/her sanction Order, Component-wise break-up of the funds so released / utilized. A copy of sanction shall also be sent to this office and Administrative Department for information and record.
2. That the funds shall be utilized exclusively for the purpose for which these are released and as per the terms and conditions contained in the Administrative Approval of GOI conveyed vide F. No: 4-1(8)/2014-CD.II dated: 20.05.2014.
3. That all the codal formalities are observed before incurring the expenditure.
4. That no diversion or Re-appropriation of funds is allowed in any case without the prior approval of the Competent Authority.
5. That the expenditure be restricted to the extent of funds released and within the approved outlays of the APIP 2014-15.
6. The funds sanctioned for Up-gradation should also be used for construction of at least one Toilet at Anganwadi Centre owned by the department where ever required.
