- The expenditure shall be incurred only for the nutrition items approved by the DLPC constituted for the purpose after fulfillment of all codal/procedural formalities as envisaged under ICDS norms/guidelines.**
- The Watch & Ward Charges if any shall be met out, out of the released funds.
- That no diversion or re-appropriation of funds is allowed in any case without the prior approval of the competent authority.
- The utilization certificate of these funds should reach this office within fortnight.
- No funds shall be released without the prior approval of the **DLPC** where the supplier has failed to make full supplies or has supplied sub-standard items under the supply order issued to him by the DPO/CDPO.


