Subject: Provisional Merit List of Sahakiyas (Anganwadi Helpers) of Poshan Project Chadoora (Phase-V).

In pursuance of Government Order No. 103-JK(SWD) of 2023 dated 28-04-2023, and in accordance with the approval accorded by the Mission Director, Poshan, vide Communication No. MD/Poshan/22200-22208 dated 18-06-2026, as conveyed by the District Programme Officer, Mission Poshan, Budgam, vide Communication No. PO/ICDS/Misc/130-140 dated 19-06-2026, an advertisement notice was issued inviting applications from eligible female candidates for engagement against four (04) vacant posts of Sahayikas (Anganwadi Helpers) in the Anganwadi Centres (AWCs) falling under the jurisdiction of Poshan Project Chadoora during Phase-V.

Accordingly, the posts were advertised vide Advertisement Notice No. 01 of 2026 dated 24-06-2026, issued under endorsement No. CDPO/Poshan/Chd/2026/Adv/673-684 dated 24-06-2026, for selection of four (05) Sahayikas (Anganwadi Helpers) for the Anganwadi Centres of Poshan Project Chadoora.

In response to the said Advertisement Notice, twenty (20) application forms were received. The merit of the candidates was assessed and the merit list was prepared strictly in accordance with the criteria laid down under Government Order No. 103-JK(SWD) of 2023 dated 28-04-2023.

Accordingly, the **Provisional Merit/Selection List** has been prepared on the basis of merit and is appended as **Annexure-A**, comprising four (05) candidates provisionally selected for engagement as Sahayikas (Anganwadi Helpers) against the vacant posts.

The Provisional Merit List for each Ward has been thoroughly scrutinized by the members of the Selection Committee, and the most eligible candidates, in accordance with the prescribed merit criteria, have been provisionally selected against the respective vacant posts.

The **Provisional Merit List** is hereby published for the information of the general public and for inviting objections/appeals, if any. Such objections/appeals shall be submitted in writing to the **Office of the District Programme Officer, Poshan, Budgam, or the Office of the Child Development Project Officer, Chadoora**, within ten (10) days from the date of publication of this notice.

No objection/appeal shall be entertained after the expiry of the stipulated period.
