In response to the said advertisement notice, 22 application forms were received against (04) posts of Sanginis (AWWs) on the basis of Wards within cut-off date i.e. 15-01-2026 and due to poor response the said advertisement has been extended by this office vide endorsement No. CDPO/W/ESTT/2025-26/524-36 Dated 15-01-2026 upto 20th Jan-2026 and merit list of candidates has been prepared as per criteria laid down vide Government Order No.103-JK(SWD) of 2023 Dated: 28-04-2023 and Tentative selection list has been framed on the basis of merit list herewith as Annexure-A, comprising of 04 candidates Tentatively selected as Sanginis (Anganwadi Workers).
